# 1. BACKGROUND AND CURRENT SITUATION

1.1. The Primary Care Operational Management Group met on Tuesday 23<sup>rd</sup> May 2017 and this report is a summary of the discussions which took place.

## 2. MAIN BODY OF THE REPORT

#### 2.1. **Primary Care Quality Update**

A review of the Quality Matters regarding IG breaches is being undertaken and it was reported that no new cases or formal complaints have been received.

The Infection Prevention Team are undertaking repeat visits to those practices who were not achieving silver or gold standards within the last year.

The Friends and Family submission data submission for April 2017 was shared with the Group. It was reported that there are fewer Friends and Family responses than the previous month. The number of practices with no data submissions has increased and this issue is being investigated.

## 2.2 General Practice Forward View Implementation Plan update

A report was presented providing an overview of the projects currently implemented, and planned for the duration of the GP 5 Year forward view. It highlighted many of the projects were already in progress and being led locally by the CCGs Task and Finish Groups working to deliver the Primary Care Strategy. There were a number of projects which are due to be released nationally and will be monitored and included on the programme of work when details become available from the General Practice Transformation Board (NHS England).

#### 2.3 General Practice Enhanced Standards Report

The group were asked to review a revised GP Enhanced Standards audit to determine if this approach should be adopted by the CCG. The report was to provide assurance of the new Infection Prevention Guidance for General Practice that aims to ensure the quality of practice, equipment and environment are compliant with national standards in order to minimise infection in GP surgeries. The report has previously been agreed at the CCGs Quality and Safety Committee and the standards have been agreed and not operational from the 1<sup>st</sup> April 2017 in vertically integrated practices. Feedback from LMC has been that they intend to advise practices to maintain national rather than local standards.

#### 2.4 Estates Update

A prioritisation estates survey is due to be shared with the Governing Body as part of a decision making process for prioritisation of estates within Wolverhampton.
